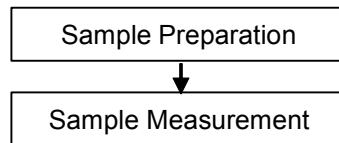

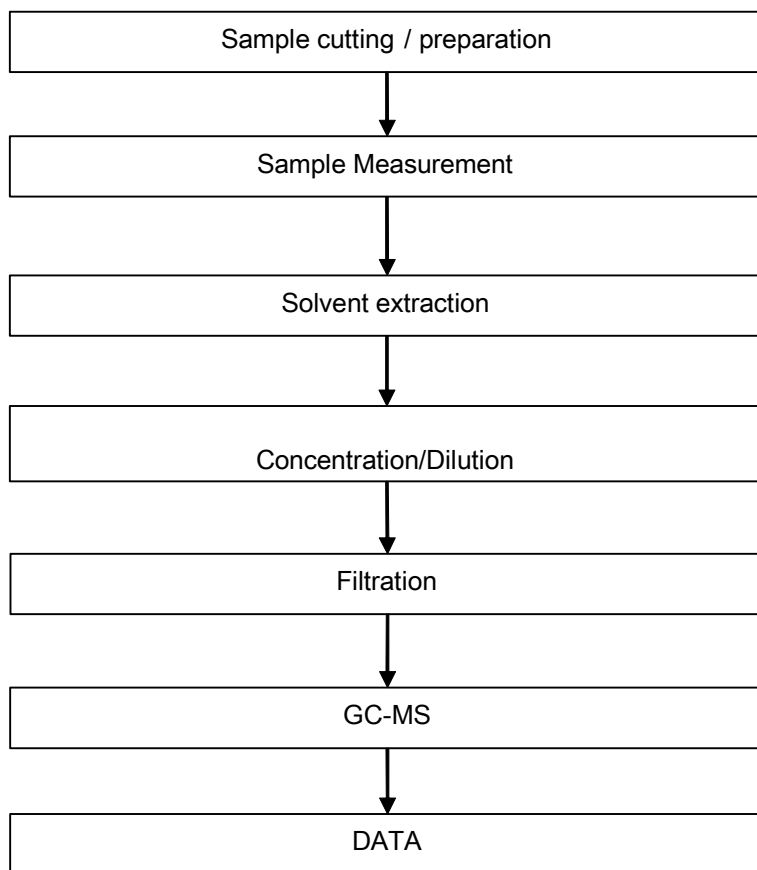
**Pb/Cd/Hg/Cr<sup>6+</sup>/PBBs/PBDEs Testing Flow Chart**

(Cr<sup>6+</sup> and PBBs/PBDEs test method excluded).

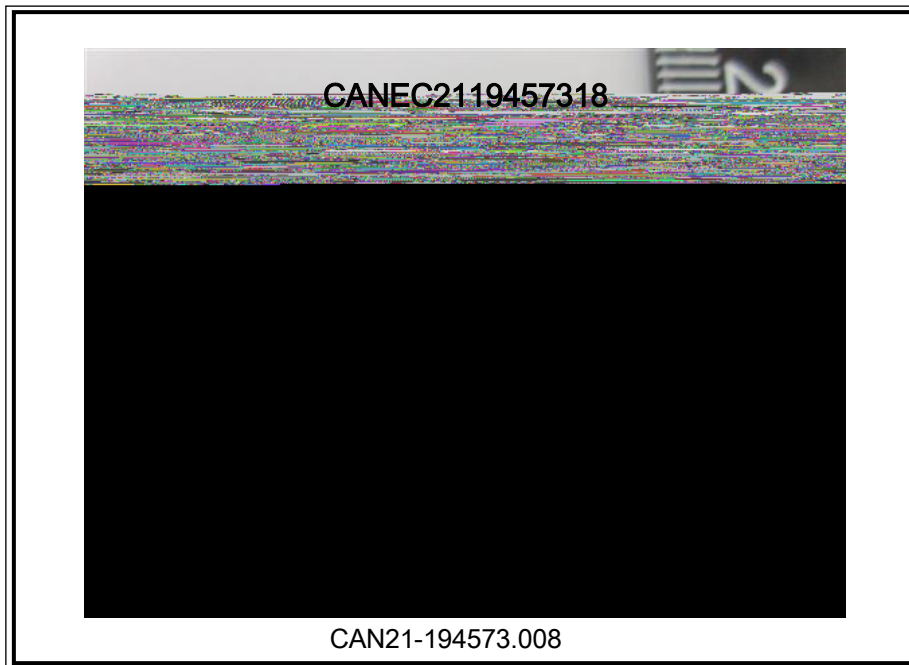
